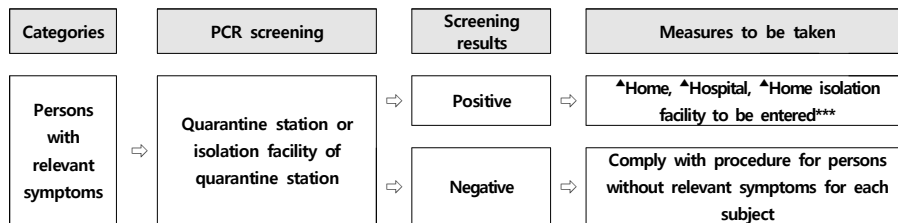


Flow chart for quarantine control of overseas arrivals (for airport arrivals)

<23. 1. 4. Immigration Management Team of Quarantine Headquarters >

- ◆ **Obligatory use of Q-CODE by arrivals from China ('23.1.2. 00:00 ~ (based on arrival time)**
 - Input quarantine information in Q-CODE and complete issuance of QR Code prior to boarding plane
 - ※ Use Chrome, Safari, and Samsung Internet browsers when entering Q-CODE on mobile (WeChat is not supported)
- ◆ **Obligatory PCR screening within 1 day of arrival for those coming from China ('23.1.2. 00:00~)**
 - Upon entry, register the screening results in Q-CODE website after having completed PCR screening within 1 day of arrival (within the date immediately after the date of arrival)
 - * Access Q-CODE website (cov19ent.kdca.go.kr) → Select 'Register screening after arrival'
- ◆ **Obligatory screening prior to arrival for those coming from China ('23.1.5. 00:00~)**
 - **Must bring PCR Negative Confirmation Certificate for screening conducted within 48 hours or RAT Negative Confirmation Certificate for specialists for screening conducted within 24 hours** with 00:00 of the date of departure as the reference (those without such certificate won't be allowed to board the plane)
 - ※ For more details, refer to [Website of KDCA] - [Notices] - [Public announcements] - 'FAQ on submission of Negative Confirmation Certificate for overseas arrivals coming from China'
- ◆ **Obligatory screening and use of Q-CODE prior to arrival for entrants coming from Hong Kong and Macao ('23.1.7. 00:00~)**
 - Make sure to bring **PCR Negative Confirmation Certificate for screening conducted within 48 hours or RAT Negative Confirmation Certificate for specialists for screening conducted within 24 hours** with 00:00 of the date of departure as the reference **and complete inputting of the relevant results into Q-CODE**

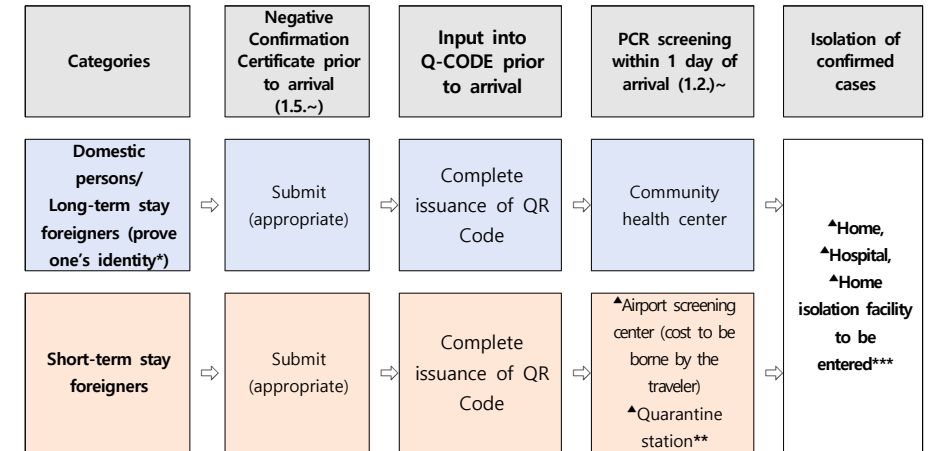

○ Arrivals from China

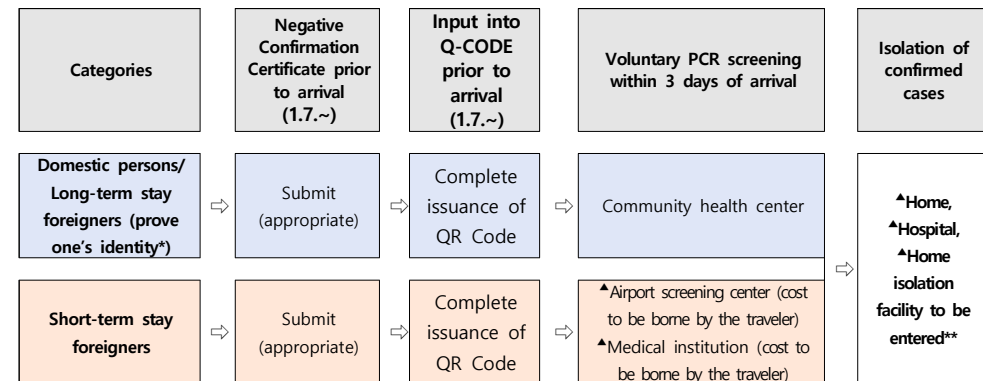

*** (Home isolation facility to be entered) Corresponds to confirmed foreigners without symptoms or mild symptoms with no definite residence in Korea.

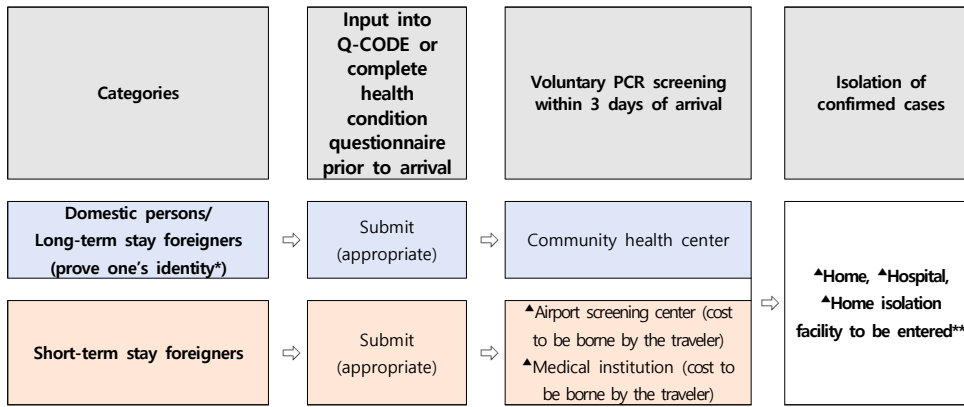
○ Arrivals from Hong Kong and Macao
